PLEASE NOTE

Any bookings are made on the understanding that, whilst you will be granted exclusive use of our function areas, it is within an operational Surf Life Saving Club building and lifesavers, members and their guests may be present in other parts of the venue. Our Licensee Trading Hours are 10:00AM to 12:00AM Monday-Sunday (excluding Christmas Day, New Year's Eve, Good Friday and Anzac Day of which are prescribed in the Liquor Act 1992).

CONFIRMATION & DEPOSIT

Confirmation of a function booking must be in writing and accompanied by the venue hire fee amount as applicable to secure the date and venue hire. Management reserves the right to cancel any unsecured bookings without notice if a confirmation has not been received.

CANCELLATIONS

Cancellations of a function booking must be in writing. If a cancellation occurs up to 90 days prior the date, the deposit will be reimbursed less our administration fee of \$100. If cancellation occurs within 14 days of your function, there is no refund of function payments. Management reserves the right to refuse any booking at any time.

FINAL NUMBERS

Final Numbers are due two weeks prior to your function. If numbers drop after this confirmation you will be charged for the initial confirmed numbers. If you need to add numbers, depending on how late notice, we may be able to add extra guests.

FOOD SERVICE TIMES

To assist the kitchen in the operation of our daily lunch and dinner services, food times for functions will be agreed upon prior to (or on commencement) of the function and then cannot be changed unless agreed upon by the kitchen.

PAYMENT

Full payment of your account is to be received 14 days prior to your function. You will be charged for final numbers. If payment and contract is not received 14 days prior, management reserves the right to cancel your booking.

DAMAGES & WASTAGE

You assume the responsibility for damages caused by yourself and your guests. Leftover food and beverages are not permitted to be removed from the premise – Nobby's Beach Surf Club does not hold a take-away food license. Under NO circumstances is confetti allowed into any function, not on tables or in balloons. An additional \$50 cleaning fee will be added to your bill if confetti is brought into the venue. If there is any damage to linen it will incur a \$30 damage fee per table cloth.

18TH & 21ST BIRTHDAYS

It is at the discretion of the club if we feel security is required for any 18th or 21st birthday event. This will be at the cost of the client if we deem the function requires security. ALCOHOL & THE LAW Alcohol may only be consumed by patrons over the age of 18. Photo proof of age may be requested at any time by the venue. Under no circumstances may alcohol be brought on to the premises. As the Balcony function area is part of Nobby's Beach Surf Club, all responsible service of alcohol laws apply. Management reserves the right to refuse entry or service and remove any individual or group without notice. Drugs are not permitted on site at any time, any drug use by any attendees may result in your function being shut down and no refunds will be given.

MUSIC

Music is NOT permitted on the balcony at anytime during functions due to restrictions on our liquor license.
